### [From Paws to Prevention: How USDA-ARS and Trained Dogs Are Helping the Citrus Industry](#)

When the American citrus industry, worth a juicy \$3.35 billion in Florida and California, faced a tough adversary in the form of the devastating Citrus Greening disease, researchers from the U.S. Department of Agriculture had to think outside the crate. They worked with an industry partner to train "detector dogs" to sniff out Citrus Greening bacteria in trees early enough to stop it from spreading.



## [FBI Signs CRADA With UC Berkeley Center for Security in Politics](#)
